Echo will run from Eureka, California to Singapore, with a stop-over in Guam, and thereto in Indonesia. Google is only investing in Echo, Facebook is investing in both cables. Need: The current COVID-19 pandemic across the globe has increased the need for reliable Internet access. And, this will provide vital new connections between the Asia-Pacific region and North America and increase the overall transpacific capacity by 70 per cent.

[SOL] Option A is correct: Recently, Wildfire had spread across several zones in Bandhavgarh National Park. It is the most popular national park in India is located in the Vindhya Hills of the Umaria district in Madhya Pradesh. It was declared a national park in 1968. The name Bandhavgarh has been derived from the most prominent hillock of the area of Umaria.

The area of Bandhavgarh is being flourished with a large biodiversity, the place which is also famed to grasp the highest density of tiger population in India.

[SOL] Statement 1 is not correct: In India's development plan exercise we have two types of schemes i.e central sector and centrally sponsored scheme. Under Central sector schemes, it is 100% funded by the Union government and implemented by the Central Government machinery. Central sector schemes are mainly formulated on subjects from the Union List. Under Centrally Sponsored Scheme (CSS) a certain percentage of the funding is borne by the States in the ratio of 50:50, 70:30, 75:25 or 90:10 and the implementation is by the State Governments.

Statement 2 is not correct: Centrally Sponsored Schemes are formulated in subjects from the State List to encourage States to prioritise in areas that require more attention.

Statement 3 is correct: The centrally sponsored schemes are divided into two categories – core of the core schemes and core schemes. MGNREGA or the Mahatma Gandhi National Rural Employment Guarantee Act falls under the Centrally Sponsored Schemes: Core of the core schemes.

**[SOL]** Statement 1 is not correct: The Central Information Commission was established by the Central Government in 2005. It was constituted under the provisions of the Right to Information Act (2005). Hence, it is not a constitutional body.

Statement 2 is not correct: The Commission can order an inquiry into any matter if there are reasonable grounds (suo- moto power). While inquiring, the commission has the power of the civil court in certain matters.

Statement 3 is not correct: The Commission consists of Chief Information Commissioner and not more than ten information commissioners. They are appointed by the President on the recommendation of a committee consisting of the Prime Minister as Chairperson, the Leader of Opposition in the Lok Sabha; a Union Cabinet Minister to be nominated by the Prime Minister.

Under Article 155 of the Constitution, the Comptroller and Audit General of India shall be appointed by the President by warrant under his hand and seal. This means that the appointment letter bears the signature and seal of the President of India. The rest of the appointments don't require the signature of the President as he can delegate this to other authority. In that case the appointment letter will bear the signature of the respective authority.

**[SOL]** In News: At the ministerial meet of the BIMSTEC, Bay of Bengal Initiative for Multi-Sectoral Technical and Economic Cooperation, India reiterated to make it a stronger, vibrant and result-oriented grouping.

Statement 1 and 3 are not correct: BIMSTEC is a regional organization comprising seven Member States lying in the littoral and adjacent areas of the Bay of Bengal constituting a contiguous regional unity. Members: India, Thailand, Myanmar, Nepal, Bangladesh, Sri Lanka and Bhutan. The BIMSTEC region is home to roughly 22 per cent of the global population with a combined GDP of over USD 2.7 trillion.

[SOL] In News: According to the Reserve Bank of India, India's current account deficit narrowed to 0.2 percent of the GDP in the December quarter as against 0.4 per cent of GDP in the year-ago period.

Option A is correct: In simple terms, the current account measures the flow of goods, services, and investments into and out of the country. It represents a country's foreign transactions and, like the capital account, is a component of a country's Balance of Payments (BOP). The Current Account Deficit (CAD) is the shortfall between the money flowing in on exports, and the money flowing out on imports. Current Account Deficit and Fiscal Deficit (also known as "budget deficit" is a situation when a nation's expenditure exceeds its revenues) are together known as twin deficits and both often reinforce each other, i.e., a high fiscal deficit leads to higher CAD and vice versa.

**[SOL]** In News: Recently, Russian scientists have deployed Baikal-Gigaton Volume Detector (GVD) in the waters of Lake Baikal, Russia.

Statement 1 is not correct: Neutrinos are the smallest particles currently known and about a thousand trillion of them pass through a human body every second. Nearly massless subatomic particles, they are the second most abundant particles after photons (particles of light).

Statement 2 is correct: They do not carry a charge and subsequently do not interact with matter, hence are not easy to catch.

Statement 3 is correct: They can be detected in water or ice as they leave a flash of light or a line of bubbles when they interact. To capture these signs, large detectors and GVD have been designed to detect high-energy neutrinos that may have come from the Earth's core, or could have been produced during nuclear reactions in the Sun.

[SOL] In News: The President of India has promulgated the Tribunals Reforms (Rationalisation And Conditions Of Service) Ordinance, 2021.

Statement 1 is not correct: Article 123 of the Constitution grants the President certain law making powers to promulgate Ordinances. Under the Constitution, the power to make laws rests with the legislature, however, in cases when Parliament is not in session and 'immediate action' is needed, the President can issue an ordinance.

Statements 2 and 3 are correct: Ordinances must be approved by Parliament within six weeks of reassembling or they shall cease to operate. An ordinance may have retrospective effect and may be modified to repeal any act of Parliament or even another ordinance. [SOL] In News: The Defence Research and Development Organisation (DRDO) has developed three variants of a 'Chaff Rocket'.

Option A is correct: The DRDO's facility Defence Laboratory Jodhpur (DLJ) has indigenously developed three variants of this critical technology: Short Range Chaff Rocket (SRCR), Medium-Range Chaff Rocket (MRCR) and Long Range Chaff Rocket (LRCR). The chaff system basically comprises multiple barrel launchers (Port and Starboard configuration), with each launcher possessing a built-in stabilization system against roll, pitch and yaw motions. It will protect naval ships against enemy missile attack. It is primarily a mechanism that when fired acts as a decoy to deflect the guiding mechanism of enemy missiles. The successful development of Advanced Chaff Technology is another step towards Atmanirbhar Bharat.

**[SOL]** In News: The central government promulgated an ordinance allowing the use of pre-packs as an insolvency resolution mechanism for Micro, Small and Medium Enterprises (MSMEs) with defaults up to Rs. 1 crore, under the Insolvency and Bankruptcy Code (IBC).

Statement 1 is correct: A pre-pack is the resolution of the debt of a distressed company through an agreement between secured creditors and investors instead of a public bidding process.

Statement 2 is correct: Pre-packs are largely aimed at providing MSMEs with an opportunity to restructure their liabilities and start with a clean slate while still providing adequate protections so that the system is not misused by firms to avoid making payments to creditors.
